

Local competence


- District (Entrepreneurship) Offices Slovak natural person according to residential address
 - Slovak legal person according to the address of seat of business
- District (Entrepreneurship) Offices in the seat of the region
 - foreign person according to the address of place of business or the address of place of business of the organisational unit
 - trade pursuant to special regulations

Territorial network

- District (Entrepreneurship) Offices
 - for trade pursuant to Trade Licensing Act
- · District (Entrepreneurship) Offices in the seat of the region
 - for foreign persons
 - for trade pursuant to special regulations




Building of the PSC in SVK


Data Exchange Between the PSC & Institutions **EU**GO

Data Exchange Between the PSC & Institutions








Building of the PSC in SVK






Life Cycle of the Request




Applications to Tax Offices (10/2007 – 08/2010)






Applications to Health Insurance Companies (10/2007 – 08/2010)






Applications to Companies Register (06/2010 – 08/2010)

- Custom Office
- Municipalities

Increase in Number of IMI Users

- increase in number of Offices registered in IMI system
- Final target on the 1st of January 2012:
 - all services of the PSCs will be available on-line
- Future ambitions:
 - the PSC acting as integrated utility place of Public Administration for tradesmen
