We plan to implement a social service involving the implementation of a training housing model dedicated to young adults transitioning to independence, leaving foster care institutions and reformatory-educational facilities. This service fills an existing systemic gap and is a necessary and important solution supporting the process of independence, vocational activation, education, and combating homelessness and housing insecurity and criminalization of young people, especially from disadvantaged groups (experiencing violence, experimenting with alcohol and psychoactive substances, having criminal experiences, individuals with disabilities, especially intellectual and psychological ones).</p> <p>The Training Housing Program supports young adults transitioning to independence, implemented by the Foundation for Activation and Integration. Started in 2021 in Świecie County, it's expanded to Toruń since January 2024. It addresses the needs of those leaving foster care, with plans to develop model solutions for wider implementation. The Regional Center for Social Policy is interested in cooperation with other European partners. This cooperation involves exchanging experiences to develop the best possible solution as a basis for implementing a solution in the country (two Training Housing Program models will be created: 1 local - dedicated to counties/municipalities, focused on service for young adults leaving foster care institutions at the level of the appropriate county, and 2</p> |
